Open to all AKC Registered and Mixed Breeds (via AKC Canine Partners).

Each dog must be individually registered with the AKC. This includes all AKC registered purebreds, Foundation Stock Service (FSS), Purebred Alternative Listing (PAL), and AKC Canine Partners Spayed or Neutered dogs, or dogs with breed disqualifications may be entered. If **not AKC registered**, you can register your Canine Partner with AKC at the event, and your dog can participate in the tests that very same day.

EVENT DAY PROCEDURES

Each dog will be inspected by the Inspection Committee for lameness, fitness to compete, and females in season. All dogs to be inspected must be presented without tape, bandages, or wrapping/coverings of any kind (coats, blankets, etc.). If, in the opinion of the inspection committee, a dog is found to be lame, unfit to compete, or in season, the dog will not be allowed to test, and the applicable entry fees will be refunded. Dogs must be inspected prior to EACH run.

Dogs will be brought to the start line on leash and released upon a verbal signal ("Tally-Ho!") from the Huntmaster or once the lure starts moving. Dogs may be released by hand, folded leash, or using a traditional lure coursing slip lead.

Dogs may run with or without a collar. Owners may use clips or rubber bands to hold the dog's hair. **The owner assumes responsibility for the safety of the dog regarding the dog's collar and paraphernalia on the dog.** Electronic training collars or pinch/prong collars are NOT allowed on AKC test grounds.

FAST CAT

The Fast CAT is a timed straight race of 100 yards where a dog chases a lure. Dogs run singularly and earn points based on their handicapped speed. There are no placements. Titles are issued at designated benchmarks. The dog's time to complete the 100-yard dash is converted into MPH. Dogs earn points based on their handicapped speed.

A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:

- 18" or greater = handicap is 1.0
- 12" up to less than 18" = handicap is 1.5
- Below 12" = handicap is 2.0

Points = MPH multiplied by the dog's handicap

Fast CAT titles suffix titles are earned at designated milestones:

- BCAT = 150 points
- DCAT = 500 points
- FCAT = 1,000 points
- FCAT# = every additional 500 points

The AKC Fast CAT website will feature the Top 20 Fastest Dogs by Breed by Year national standings. The standings will be updated as event results are processed.

PHOTOGRAPHY

If there is an official photographer for these events, no other photographer will be allowed to photograph dogs/people without the express consent of the lead photographer and the Field Trial Chairman. (Only exception is persons with cell phones and their own dogs). Anyone caught photographing these events, or any portion thereof, without permission will be asked to leave the field. An AKC Event Committee hearing may also be called if unsportsmanlike behavior is evident.

MISCELLANEOUS

- Open to all dogs at least 12 months of age that are individually registered/listed with the AKC. This includes dogs recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program. (An event number defines an event.)
- **Lure Equipment:** Battery-powered, continuous loop equipment will be used. Lures consist of white plastic bags. Electronic break-the-beam timing system will be used with manual timing as a backup for equipment failure and rainy weather.
- For the safety of the dog and as a courtesy to other entrants, a testing dog should have a reliable recall. A penalty of **\$5.00** may be assessed for any dog causing an excessive delay of the event because it cannot be recalled or retrieved from the field. Dogs that delay the event because their owners cannot **recall them may be refused entry at future events.**
- You will be charged \$5.00 if you do not pick up after your dog.
- These events will be run concurrently. Dogs that have not yet run will have priority over dogs that will be running for the second test.
- Event is held in rain-or-shine - outdoor event. Please plan accordingly.
- Dogs should be walked prior to running to warm them up and again after their run to cool them down.
- The handler may NOT run down the course to entice the dog to run or use toys/treats to get the dog to run. They CAN call their dog from the catch area. Handlers may carry toys or treats on their persons to assist with retrieving their dogs at the completion of their run. Please review the published AKC rules pertaining to Fast CAT.
- Dogs must be on lead or crated unless running.
- Handlers should wear comfortable shoes and be physically able to hold and release their dogs, as well as catch them.
- Lure coursing is a physically demanding sport so please make sure your dog is in good shape. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded.
- Any person, upon reasonable complaint, may be asked to leave the grounds of the test by the Field Committee and may be disciplined by the AKC. Children must always be under control of their parents or guardian(s).
- Each dog requires an entry form.
- Late, incomplete, unsigned, unpaid, or conditional entries, or entries not containing the "Agreement" found on the Official AKC Entry Form will not be accepted.
- Mixed breeds must be spayed or neutered to be eligible to run. AKC registered dogs with breed disqualifications may be entered.
- **No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.**
- **No refunds for early entry fees unless the entered dog upon inspection is lame, unfit to compete, or in season.**
- A return check fee of **\$40.00** will be assessed for any check(s) returned for insufficient funds.

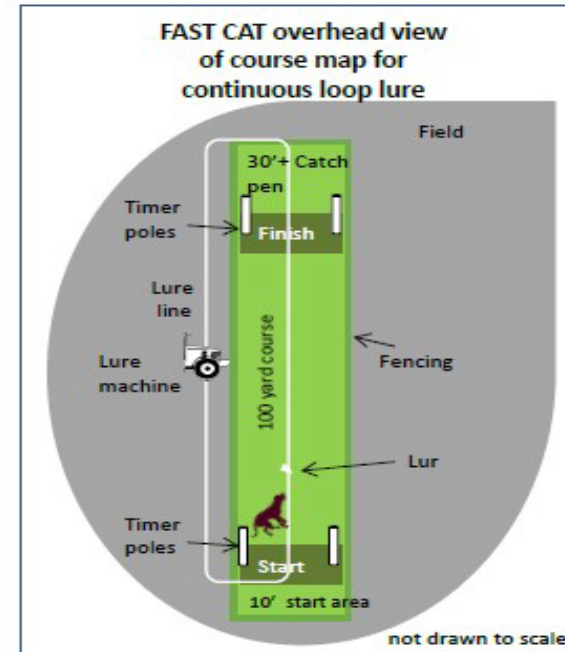

The AKC Temperament Tests (ATT) Test is open to all dogs **at least 12 months of age** that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers, or neutered dogs enrolled in the AKC Canine Partners program. Females in season may not participate. Dogs with physical challenges (including amputees) are eligible to enter provided, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the entire course.

Early Entries Close: Sunday, May 24, 2026 at 11:00:00 pm CST.

ATT Entries LIMITED to 50 runs per event number.

ENTRY INFORMATION – AMERICAN KENNEL CLUB TEMPERAMENT TEST

ENTRY FEES: **Early entries: \$35/PER DOG/per RUN**, includes AKC \$4.50 recording fee. Make checks payable to Black Knights Coursing. Day-of entries will be taken from **4:00 PM** provided there is space available for either test. **Day-of entry fee will be \$35/per dog/per run. Please note it takes two test passes to earn the title, so the cost is per test. Online entries are available at Blackknights coursing.com. If you enter online, you will be required to sign the agreement on site.**

Pre-entry online confirmations will be sent automatically. Pre-entry snail mail confirmations will be sent by e-mail provided the address is legible. All fees payable to Black Knights Coursing.

Returned Checks do not constitute a valid entry and will be subject to a **\$40 collection fee**. Owners are responsible for errors in making out entry forms and no entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Please type or print clearly & carefully the information on entry forms to eliminate errors. The Trial Secretary is not responsible for illegible (in the opinion of the Trial Sec) entry form information. BKC and/or the Jupiter Tequesta Dog Club may decline entries and may remove any dog on any account of disease, viciousness, or other cause, and no one shall have any claim against the aforementioned group or any official or member thereof. Entry fees will not be refunded in the event a dog is absent, not allowed to compete in the entered test, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbance or acts beyond the control of the management it is impossible to open or complete the test(s), no refund will be made. When entry limits are reached, all additional entries received prior to closing will be added to an alternates list in the order entry was received. The alternates list will be used to fill vacancies that occur in the drawn running order, with the first alternate entry replacing the first vacancy in the event entered. A signed consent and release from liability form must accompany each entry. Failure to do so will result in you and your dog being barred from entering the grounds and competing in these trials.

QUALIFYING RIBBONS: Each dog that passes an American Kennel Club Temperament Test will receive a royal blue ribbon provided by Black Knights Coursing.

Dogs that pass AKC Temperament Tests under two different judges are eligible for a AKC Temperament Test Title and a red, white, and blue rosette. Please go to the AKC Title Portal at <https://www.apps.akc.org/title-application-portal/> An application form for the title is included in the premium list for the convenience of exhibitors. Owners will need to complete the application form and send it and the appropriate fee to the American Kennel Club.

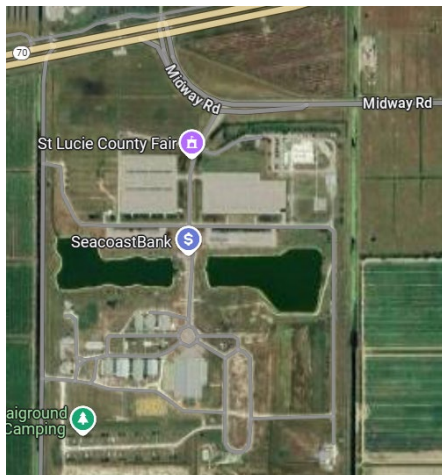
